This document is a NOTICE TO INITIATE AND PROCEED TO ARBITRATION of all disputes as to the Stipulation and Settlement Agreement of May 22, 2015, by and between the parties thereto, being: Bradley Christopher Stark and Shawn Michael Rideout ("Claimants") versus the United States of America ("Respondent"). This Notice is in compliance with Section 2 of title 9 of the United States Code, and Section 16-4409(a) of the D.C. Code.

The nature of the controversy is:

- 1. Failure to voluntarily comply with the terms of the Stipulation and Settlement Agreement of May 22, 2015 ("Agreement");
- Failure to voluntarily comply with the terms of the Arbitration Award on Contract 917092-B1/USAG;
- 3. Continued deprivation of liberty, property, and risk to life and limb as to Claimants, in violation of the Constitution of the United States of America, the Treaties and Laws of the United States, etc.; and
- 4. Willful and wanton official misconduct and negligence, negligence in law, negligence per se, deliberate indifference, and intentional execution and enforcement of misconvictions operating upon Claimaints by the Respondents, et al.

The remedies sought for resolution of the controversy and dispute(s) under the Agreement include, but are not limited to:

- 1. All remedies expressed in the Agreement and available by law, e.g.:

 - d. All property returned to the Claimants according to the Agreement or fair and just pecuniary compensation in the alternative;
 - e. Expungement of all records relating to the Claimants and the beneficiaries under the Agreement; and
 - f. Immediate payment of actual damages as stipulated in the Agreement, including, but not limited to any an all other relief as expressed in the Agreement and available by law.
